RU - Russian Federation (Third Countries group)

FP7 Key facts and figures

Applications:

As of 2012/10/18, a total of

- 1.797 eligible proposals were submitted in response to 355 FP7 calls for proposals
- involving 2.598 applicants from Russian Federation (9,53% of Third Countries) and
- requesting EUR 370,31m of EC contribution (11,96% of Third Countries)

Among the Third Countries Russian Federation (RU) ranks:

- 2nd in terms of number of applicants and
- 1st in terms of requested EC contribution

Success rates:

- The RU applicant success rate of 22,7% is similar to the Third Countries applicant success rate of 23,4%.
- The RU EC financial contribution success rate of 16,7% is lower than the Third Countries rate of 18,2%.

Specifically, following evaluation and selection, a total of

- 373 proposals were retained for funding (20,8%)
- involving 590 (22,7%) successful applicants from Russian Federation and
- requesting EUR 61,85m (16,7%) of EC financial contribution

Among the Third Countries, Russian Federation (RU) ranks:

- 71st in terms of applicants success rate and
- 80th in terms of EC financial contribution success rate

Signed grant agreements

As of 2012/10/18, Russian Federation (RU) participates in

- 282 signed grant agreements
- involving 4.560 participants of which 450 (9,87%) are from Russian Federation
- benefiting from a total of EUR 1.284,64m of EC financial contribution of which EUR 60,47 m (4,71 %) is dedicated to participants from Russian Federation.

Among the Third Countries in all FP7 signed grant agreements, Russian Federation (RU) ranks:

- 1st in number of participations and
- 1st in budget share

SME performance and participation

- The RU SME applicant success rate of 17,68% is similar to the Third Countries SME applicant success rate of 18,38%.
- The RU SME EC financial contribution success rate of 12,19% is lower than the corresponding Third Countries rate of 14,70%.

Specifically,

- 639 RU SME applicants requesting EUR 101,96m
- 113 (17,68%) successful SMEs requesting EUR 12,43m (12,19%)

In signed grant agreements, as of 2012/10/18,

- 37 RU SME grant holders, i.e., 8,22% of total RU participation
- EUR 5,95m, i.e., 9,84% of total RU budget share

ERC Principal Investigators and Marie Curie Fellows

- 16 RU Principal Investigator(s) (8,89% of the total 180 Principal Investigators for Third Countries) benefit from EUR 21,11m (7,49% of the total EUR 281,84m for Third Countries).
- 93 RU Marie Curie Fellow(s) (9,54% of the total 975 Marie Curie Fellows for Third Countries) benefit from EUR 14,86m (9,06% of the total EUR 164,12m for Third Countries).
