- HU-RUS Agreement on Higher Education Cooperation (signed 17.02. 2015.)

 - External Member: for Hungarians, with non-Hungarian citizenship;
 - Hungarian Science Abroad Presidential Committee;
 - Homeland Research Programme (for Hungarian scientists, living in the neighbouring countries)

Innovation

- National Research, Development and Innovation Office (Since 01.01.2015)
 - Harmonisation of domestic and EU co-financed R&D financial sources;
 - Responsibility for the whole chain (from research to innovation: basic R, Applied R&D, market and end-user oriented innovation processes);
 - Domestic financial source: National Research, Development and Innovation Fund;



- Hungarian Scientific Research Fund (OTKA)
 - International cooperation in basic research (ERA-Chemistry, CONCERT-Japan, M-ERA-NET, Infect-ERA, E-Rara, NN etc.)
- Jeremie Programme (for the domestic SME-s)

 - Central Europe 2014-2020 Programme

 - HU: 96 M EUR, SK: 60 M EUR
 - Transport: 25 new road connection up to 2020
- HU-AT CBC Programme
 - HU: 32 M EUR, AT: 45 M EUR
 - SMEs, environmental protection, green transport
 - GERD/GDP: W-Transdanubia: 0,6%
 - Burgenland: 0,8%
 - Steiermark: 3,9 %
 - Vienna: 4,0 %



Running CBC Programmes (2014-2020)

- HU-RO CBC Programme
 - HU: 93 M EUR, RO: 96 M EUR
- HU-HR CBC Programme:
 - HU: 35 M EUR, HR: 20 M EUR
- HU-SLO CBC Programme:
 - HU: 10 M EUR

- HU-SRB IPA CBC Programme
 - HU: 33 M EUR
- HU-SK-RO-UKR ENI CBC Programme
 - HU: 23 M EUR
