ITN Innovative Training Networks

What does it offer? High-quality research training delivered through international and interdisciplinary networks, industrial doctorates or joint doctorates

Who applies? International networks of research organisations from the academic and nonacademic sectors

Who is funded? Researchers at doctoral level (less than four years of full-time research experience and no doctoral degree)

What does it offer? The exchange of staff members

Individual fellowships: key features

- Focus on CAREER DEVELOPMENT through RESEARCH, INTERNATIONAL and INTER-SECTORAL MOBILITY and ADVANCED TRAINING. A career Development Plan has to be developed on training and career needs including training on transferrable skill, teaching, publications, etc..
- Only EXPERIENCED RESEARCHERS (PhD or > 4 years full time equivalent research experience) of ANY NATIONALITY apply together with an INSTITUTION (BENEFICIARY) located in an EU Member State or Associated Country
- BOTTOM-UP Programme addressing all scientific fields; EXCELLENCE-driven
- SECONDMENT possible to another organisation (academic or non acdemic) within Europe (up to 6 months)

MSCA Calls

- Ca. 10,000 proposals received per year (funding for ca. 1,500)
